General Information

1. No entry will be accepted unless all particulars called for on the entry form are completed in full. Handlers and agents please note that the full name and address of all owners must be filled in. Incomplete entries will be returned. The Trial Committee reserves the right to refuse any entry as prescribed by the CKC rules. Exhibitors must abide by the errors made in entering their dogs, regardless of how or by whom the entries were made.
2. The Trial Superintendent will be in full charge of the show.
3. Dogs should be on the trial grounds one hour prior to the judging of their event. It will be the responsibility of the exhibitor to have his/her dog at ringside when it is required for judging. Handlers are requested to report any absentees and have assistants at ringside if they are engaged elsewhere. Dogs not required for further judging may be excused.
4. Entry fees shall not be refunded in the event that a dog is absent, sick, or excused by a veterinarian or judge, or barred from competition by action of the Trial Committee, or because it is entered incorrectly.
5. Crocus Obedience and Kennel Club will use due care and diligence for the welfare of the dogs and exhibitors but will not be responsible for, or assume any liability, in the event of an accident or other misfortune to either dogs, exhibitors, or patrons.
6. If, because of riot, civil disturbance, or other acts beyond the control of the management, it is impossible to open or to complete the trial, no refund of entry fees will be made.
7. ALL DOGS MUST BE KEPT UNDER CONTROL AT ALL TIMES.
8. There will be exercise areas provided and exhibitors are required to take their dogs to these areas for exercise purposes, so that the general grounds can be kept as clean as possible. EXHIBITORS ARE RESPONSIBLE FOR CLEANING UP AFTER THEIR DOGS-THERE IS A \$50.00 FINE IN BRANDON FOR FAILING TO CLEAN UP PET WASTE ON PUBLIC PROPERTY.
